- Please PRINT & Sign the FBI Affidavit: <u>Disclosure Statement Application for</u> <u>Volunteers</u>
- Coach will need to sign in the presence of a NON-AMILY MEMBER WITNESS who will also sign the document.
- Scan, save, and upload.

I have NOT lived in PA for the Past 10 Years:

- You will need to complete FBI Fingerprinting.
- Please contact us ASAP if you will need to complete fingerprinting as this process can take some time. **
- If you have recent fingerprint results from the past 5 years, you can submit those results and avoid completing this process.
